Additional Membership Types:

☐ Student Membership – US \$35

IAEE offers student membership to any individual who is engaged, full or part time, in a program at a college or university. Student Members are eligible to enjoy all IAEE benefits; however, their status is non-voting. Submission of an official course schedule is required.

☐ Faculty Membership – US \$160

A Faculty Member is a member who is teaching or directing a program at a college or university approved by the IAEE Board of Directors. Faculty members shall not be entitled to vote, hold office or be a Director in the Corporation. Submission of proof of employment at a college or university is required.

☐ Retired Membership – US \$60

A Retired Member is an individual who has been a Member of IAEE, or a designated representative of a Voting Member of IAEE, for ten (10) or more years and who is retired and no longer employed in the exhibition industry. For the purpose of this definition, "employed" shall mean substantial remuneration for any labor. Retired Members are not entitled to vote, hold office or be a Director in the Corporation.

NOTE: IAEE Membership Dues are non-refundable.
